# COOLSAVER PROGRAM

## LANDLORD/HOMEOWNER CONSENT FORM

### OVERVIEW

The Save On Energy CoolSaver Program (the “Program”) provides incentives to eligible residents in the Richview South area in Toronto to upgrade their home cooling systems with measures that can help reduce electricity consumption.

Eligible program participants are tenants or homeowners of single-family homes, including single-detached houses, semi-detached houses, row houses, and townhouses, that meet program eligibility requirements.

For participants that are tenants, it is mandatory to have the consent of the landlord or the homeowner to install or implement eligible energy efficiency measure(s) (including replacing previously installed equipment) under the Program. In addition, the landlord or homeowner must agree not to remove any energy efficiency measures installed under the Program before the expected service life of the measure, unless the measure fails or is replaced by a more energy efficient measure.

As the landlord or homeowner, you are receiving this form because the Participant has submitted a Participant Intake Form to the Program that includes your home (the “Facility”).

This “Landlord/Homeowner Consent Form” and any supporting documentation attached to it confirm that you have read, understood, agreed and consented to your tenant and Facility participating in the Program.
